Equine Release and Transfer Agreement

Agreement

THIS AGREEMENT is made this 1st day of August, 2014 by and between The Wild for Life Foundation (WFLF), of 12400 Ventura Blvd, Ste 706, Studio City, CA, 91604, hereinafter referred to as INTAKE RESCUE, and Monero Mustangs, a New Mexico 501 (c)3 nonprofit corporation with its head office located at Hwy 64/84, Chama, New Mexico 87575, hereinafter referred to as SURRENDERING OWNER.

The parties hereby ACKNOWLEDGE that this AGREEMENT is made for the Transfer of ownership of HORSE(S), described as follows in paragraph "F" below, on the following terms and conditions as set forth herein.

A. SURRENDERING OWNER Urgency/ Rescue Need

The SURRENDERING OWNER has made an urgent plea to INTAKE RESCUE to rescue and take in the aforementioned HORSES as follows: their lives are in immediate danger and the SURRENDERING OWNER has no other means to save them.

B. Acknowledgements

SURRENDERING OWNER agrees to publicly acknowledge through its website, social media pages and member communications, the "Wild for Life Foundation for its generous assistance in saving, transporting, placing, taking in and providing for the care of the Monero Mustangs' HORSES in their most dire time of need".

C. Conflicts of Interest

SURRENDERING OWNER agrees not to engage in any activities which may present a conflict of interest to the INTAKE RESCUE as related to this transfer/ surrender agreement.

D. Warranties

- (1) SURRENDERING OWNER makes no other warranties, express or implied, including the warranties of fitness for a particular purpose except as may be otherwise provided for in this AGREEMENT;
- (2) SURRENDERING OWNER represents and warrants that it has clear title to said horse; and hereby agrees to execute the legal transfer for the aforementioned HORSES within the parameters of this agreement.
- (3) Vested title of said horse shall convey to INTAKE RESCUE at the time that INTAKE RESCUE or its transport takes physical possession of the HORSE(S).

E. Consideration

SURRENDERING OWNER agrees to additionally contribute equipment described as: (2) water troughs, (2) pasture feeders and (10) panels to INTAKE RESCUE to assist in the care, management and upkeep of the aforementioned HORSES.
